# Guidelines for submission of Joint Symposium Proposal

# Taiwanese-Mongolian Research Cooperation

#### **General Remarks:**

The MECS accepts only those proposals which are submitted jointly by the Taiwanese side. Each symposium shall receive a subsidy of maximum US\$30,000, convened in either Taiwan or Mongolia, and shall accommodate no less than 8-10 persons from the visiting country and no less than 10-12 persons from the hosting country. This subsidy may be applied towards international travel (from Taiwan to Mongolia), accommodation, and organization expenses. Peer scientists, scientists from other countries, and industry researchers are welcome to participate in the discussion, but shall bear the expenses by themselves.

This proposal is subdivided into:

\* MOST requires the proposal to be written in Mandarin using a specific application form (Table--IC01) which is available on the MOST website. An abstract in English is also required.

#### **General Information:**

- [1] Title (max. 260 characters, not including spaces). If, additionally, an acronym is used, it should be placed after the title.
- [2] Possible venue of the symposium
- [3] Possible date of the symposium: It should provide for duration of normally not more than three days. However, the stay of the participants from the sending side may be completed with visits of research institutes and facilities in the host country for another three days at maximum. At maximum, financial support will be granted for duration of one week including international travel.
- [4] The Taiwanese applicant, acting as organizer of the symposium, signs and submits the proposal to the MOST, thus applying for funding of the Taiwanese part of the symposium.
  - The Mongolian applicant, acting as co-organizer of the symposium, submits the corresponding version of this proposal to the MECS, thus applying for funding of the Mongolian part of the symposium.
- [5] The Taiwanese and the Mongolian applicants' curriculum vitae giving details on the academic career, the membership in societies as well as the current position. Not necessary to submit CVs of further participants.
- [6] e.g. list of relevant publications of the Taiwanese and Mongolian applicants dating back five years at maximum.

#### **Budget:**

[7] The preliminary budget must be divided into a Taiwanese and Mongolian part (both parts are calculated in US Dollars). The hosting organization – the MOST in the case

of Symposium held in Taiwan and the MECS in the case of Symposium held in Mongolia – will bear the costs of the organization or execution of the Symposium, including accommodation, meals and domestic transportation. The sending organization – the MOST in the case of Symposium held in Mongolia and the MECS in the case of Symposium held in Taiwan – will bear the international travel costs from its country. The following costs are not to be covered by the grant:

- . costs for room rentals at universities and other publicly supported institutions
- . costs for secretarial work
- . salaries of personnel involved in the organization of the symposium.

For travelling expenses, the following items cannot be declared:

- . visa application to the 3<sup>rd</sup> country
- . living expenses in the 3<sup>rd</sup> country
- . airfare not 'from' or 'to' either Mongolia or Taiwan.
- [8] For Taiwanese Side: all amounts which are being requested by the Taiwanese applicant
- [9] For Mongolia Side: all amounts which are being requested by the Mongolian applicant

#### **Contents:**

- [10] The summary must permit quick access to the research topic of the symposium, which must be devoted to basic sciences. (up to one page).
- [11] Describe the objectives of the symposium (up to one page).
- [12] State the importance of this symposium for future Taiwanese- Mongolian scientific cooperation (up to one page).
- [13] Summarize the expected scientific impact of the symposium (up to one page).
- [14] The list must include full name, position, full working address, contacts (esp. e-mail and telephone numbers) and date of birth of participants from two sides.
